Item No. 43.3: ITEMS PLACED BEFORE THE 43rd SENATE MEETING HELD ON September 15, 2017.

Discussion and Decision Items:

Item No. 43.3.1:Admission of students made under UG, PG and Ph.D
programme for the academic year 2017-18.

The Senate resolved to approve the admission of students made under UG, PG and PhD programme for the academic year 2017-18.

Item No. 43.3.2: Convocation - List of graduates- Approval of eligible candidates for the award of B. Tech / M. Tech / M.Tech (Research) / M.C.A. /M.B.A / M.Sc/ Ph.D degree during the 15th Annual convocation.

The Senate resolved to approve the list of eligible candidates for the award of B.Tech/M.Tech/M.Tech (Research)/MCA/MBA/MSc/Ph.D degrees during the 15th Annual Convocation. The Chairman-Senate was authorized to approve additional list of eligible candidates for the award of M.Tech (Research) and Ph.D degree during the 15th Convocation.

It was further resolved that the matter shall be placed before the BoG for approval.

Item No. 43.3.3: Request to condone the delay in Submission of Research Proposal.

The Senate resolved to condone the delay of submission of Research proposal by the PhD scholars Mr. Surajit Deb Verma (AM15F10), Mr Shankaranarayana K (EC15F08) who had submitted the proposal within two and a half years of PhD Registration.

It was also resolved to terminate the PhD registration of Mr. Marsh M Bandi (CV13F06) and Mr Akash Anand (CV14F12) as they had submitted the proposal after two and a half years of PhD registration. It was further resolved that those scholars who have been terminated from PhD programme due to delay in proposal submissions may submit a request for permission to reregister. The Director/Senate-Chairperson is authorized to take the decision considering the merit of the case.

Item No.43.3.4: Request to condone the delay in Submission of Ph.D Thesis.

The Senate resolved to condone the delay in submission of Ph.D Thesis by Ms. Usha D (CO11F02).

Item No. 43.3.5: Academic calendar for the academic year 2017-18 (Even Semester) and the academic year 2018-19 (Odd Semester).

The Senate resolved to approve the Academic Calendar for the Even Semester (January-May 2018) and Odd Semester (July – December 2018).

Item No. 43.3.6: Institution of Post-Doctoral Fellowships – Representation of Prof. A. O. Surendranathan, Dept. of Metallurgical and Materials Engineering.

After detailed deliberations, the Senate resolved that the existing opportunities such as DST grants and INSPIRE fellowships need to be encouraged for postdoctoral research, instead of awarding post-doctoral fellowships from the Institute funding.

Item No. 43.3.7: Nomination of one faculty from Senate to the BoG as per NIT Act 2007.

The Senate noted the subject and authorized the Secretary, Senate to conduct election for nominating one faculty from Institute to the BoG as per NIT Act 2007. It was resolved that this time the nomination would be from the cadre of Associate Professors.

Item No. 43.3.8: Induction programme for newly admitted B Tech students – Representation of TEQIP-III Coordinator

The Senate resolved to approve the Induction Programme proposed by the TEQIP Coordinator.

Item No. 43.3.9: Requirement of MLC Course, HU 800 Research Methodology, for those who have completed M.Tech (Research) at NITK and proceeding to Ph.D Programme.

Since the course credits and content are the same, it was resolved to dispense with the registration for HU800, if the scholar has completed the course during M.Tech (Research) at NITK prior to joining Ph.D programme.

Item No. 43.3.10: Any other Items with the permission of Chair

- 1. It was decided that admission to M.Tech, M.Tech(by Research) & Ph.D programmes to be on valid GATE /NET scores, except for sponsored candidates.
- 2. It was resolved that the maximum time limit for submission of Ph.D thesis is 7 years, as per applicable PhD regulations.
- 3. It was resolved that the approval for the recommendations by the HoD's to be accorded only as per rules & regulations for UG, PG, and Ph.D programmes.
- 4. The discussion towards the problem of water crisis situations faced by the Institute during February to June every year took place. It was suggested by the Senators that in such situations, to advance the closure of classes by a week by conducting of special classes on Saturdays. It was resolved to authorize the Chairman, Senate to review the position at each occasion and take appropriate decision in this regard.
- 5. Further, the Senate also discussed on the number of holidays granted for INCIDENT & ENGINEER FEST. It was proposed to reduce the duration, else compensatory classes shall be taken to provide an extra day.
